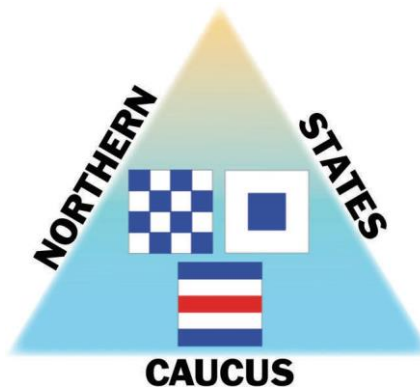


## Northern States Caucus

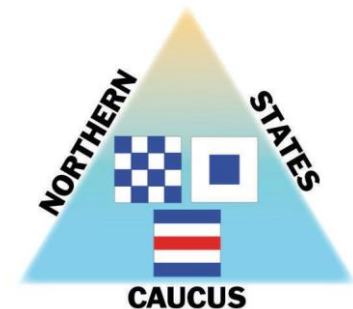

## THE SCHOLARSHIP AWARD

## GENERAL SCHOLARSHIP REQUIREMENTS

The applicant must:

- Be a full-time student from one of the Northern states\*, attending a two or four-year college or university.
- Be a strong academic performer and have at least a 3.0 grade point average on a 4.0 scale.
- Have a degree emphasis in a recreational boating safety related field (e.g. law enforcement or criminal justice, natural resources/environmental science, education, public relations/marketing or journalism).

## APPLICANTS MUST SUBMIT:

- Two recommendation letters (one from a field related faculty member and one from a professional in recreational boating safety);
- Resume noting all boating/natural resource/law enforcement related activities;
- College transcript, and
- An essay — typewritten, double-spaced, not exceeding two pages — that addresses one of the following topics:
  1. Boating Under the Influence
  2. Marketing Boating Safety
  3. Effects of Technology Advancements on Boating
  4. Boater Education
  5. Career Opportunities in Boating Law Enforcement
